




The latest available data indicates the overall Nevada economy continued to make progress toward recovery. While the recovery cycle has been asymmetrical – northern Nevada has generally outperformed the southern portion of the state – the recovery overall remains critical. Total employment in the state rose for the tenth consecutive month, increasing 7.5 percent over the year to 1.4 million employed. The unemployment rate plunged from the year before, dropping from 11.6 percent in October 2020 to 5.8 percent in October 2021. Correspondingly, monthly initial unemployment claims plummeted to 6,500 in October 2021 – a fraction of the 37,900 reported in October 2020 and the lowest value since June 1990. Additionally, conditions in Nevada's construction sector reported stability. Construction-based employment dipped slightly to 92,800 in October 2021, down 1.6 percent (-1,500) from the previous October. At the same time, permitting activity increased modestly as 1,770 new home permits were issued in October 2021. Permitting activity grew 19.4 percent from the previous year. The rise in permitting was driven by surging multi-family permits, which rose 49.6 percent from the previous year, while single-family permits reported a smaller annual growth rate, rising just 8.9 percent. Barring any significant changes, the combination of strong permitting activity and improving conditions in the state's broader labor market suggests continued stability in the construction sector.


CONSTRUCTION EMPLOYMENT




NEW RESIDENTIAL UNITS PERMITTED




TAXABLE RETAIL SALES



TOTAL EMPLOYMENT




INITIAL UNEMPLOYMENT CLAIMS




UNEMPLOYMENT RATE




AVERAGE WEEKLY HOURS - PRIVATE






GROSS CASINO GAMING REVENUE




NEW SINGLE-FAMILY UNITS PERMITTED
